to develop jointly seed and ingredients businesses in India



Limagrain, 4th international seed group, plant breeding and plant valorisation specialist, is entering in a strategic alliance with Avesthagen (Avestha Gengraine Technologies Pvt Ltd), a Bangalore based company, India leading Healthcare Technology Group, to develop jointly seed and ingredients businesses focused on Indian markets.

This strategic alliance is a long-term, mutually beneficial agreement, in which, for each project selected by Avesthagen and Limagrain, resources, knowledge and capabilities will be shared with the objective of enhancing each partner's competitive position.

Avesthagen will bring knowledge regarding Indian markets access (regulation, marketing, distribution, etc...). Limagrain and its subsidiaries will have access to various Indian technology platforms as well as access to proprietary technologies developed by Avesthagen.

Limagrain will bring knowledge in plant breeding, plant valorisation and expertise in channel production management (seed and ingredients). Avesthagen will have access to proprietary technologies developed by Limagrain.

In seed domain, the partners have decided to rapidly create a joint venture dedicated to jointly develop a first grade Seed Business Unit in India. Vilmorin & Cie and Avesthagen will be the shareholders of this new company, which will be used for acquiring seed companies and developing joint research programmes in field seeds and vegetable seeds.

In ingredients domain, the partners will develop synergies based on Avesthagen and Limagrain Cereals Ingredients existing expertise.

In biotechnologies domain, collaborations, which will take into account previously established partnerships by Limagrain and Avesthagen, will result in enlarged opportunities for creating elite varieties, matching the Indian markets needs. Further, it will bring solutions to overpass existing difficulties to operate GMO research programmes in Europe.

Daniel Chéron, Deputy CEO of Groupe Limagrain said : « With this global alliance, Vilmorin & Cie will have opportunities to speed up the development of new potential for growth already engaged in India by its vegetable subsidiaries. It will furthermore bring opportunities to operate collaborative R&D programmes in biotech, especially related to GMO's field plant trials. It will also provide development opportunities for Group Limagrain Ingredients division ».

Dr Viloo Morawala Patell, Founder & CEO of Avesthagen, said : « This alliance with Limagrain, will allow Avesthagen to develop seed and ingredient businesses while benefiting of expertise of a global player, bringing all together international dimension, strong research commitment and a close to farmers philosophy. I am convince that putting together know how of Limagrain and Avesthagen will allow building of a very competitive seed business unit in India and that Avesthagen technologies will bring to Limagrain and its partners opportunities to complement efficiently their technologies tool boxes ».
